## 2 Depository Fees

A-M Global Logistics, LLC offers storage for your IRA as Individual Sub-Accounts of Entrust; having its own reporting and physical storage per IRA. Additional details regarding the storage of metals at A-M Global Logistics, LLC may be found in the Depository Custody agreement which is available upon request. Fees are billed in advance at the time Assets are first stored, and each anniversary date for every subsequent year. Fees are neither prorated nor refundable. The fee structure is listed below.

<b>Gold/Platinum/Palladium/Silver Only</b>	<b>\$170.00 minimum annual fee</b> \$1.60 per \$1,000 (16 basis points)
<b>Outgoing Shipping and Handling Fees</b>	
A \$25.00 minimum charge per out-shipment will apply in every instance. This fee may vary depending on the desired (or required) method of transport. Client shall be liable to pay such fees as of the day it gives the Depository instructions to prepare a shipment for delivery, notwithstanding the fact that the delivery order may later be canceled by client, if in fact the Depository has caused such shipment to be prepared for delivery. Shipments will be prepared in accordance with standard Depository's practices and packaging materials.	
A-M Global Logistics, LLC offers shipping options through various carriers. Those options include Personal Pick-Ups, USPS, UPS, and FedEx. A \$19.50 per package handling fee, plus all applicable postage, registration, and insurance charges apply. There is an additional \$25 fee per transaction for internal transfers from segregated accounts.
