2 Depository Fees

CNT Depository, Inc. (CNT), offers segregated storage for your IRA as Individual Sub-Accounts of Entrust; having its own reporting and physical storage per IRA. Additional details regarding the storage of metals at CNT may be found in the **Depository Custody agreement which is available upon request**. Accounts are billed the day CNT receives your first metals deposit and every January thereafter. The fee structure is listed below.

Gold/Platinum/Palladium/Silver	\$1.00 per \$1,000 (10 basis points) \$175.00 minimum annual fee
Outgoing Shipping and Handling Fees	
A \$25.00 minimum charge per out-shipment will apply in every instance. Client shall be liable to pay shipping fees as of the day it gives Depository instructions to prepare a shipment for delivery, notwithstanding the fact that the delivery order may later be canceled by client, if in fact Depository has caused such shipment to be prepared for delivery. Shipments will be prepared in accordance with standard Depository's practices and packaging materials.	
CNT offers shipping options through various carriers. Those options include Personal Pick-Ups, USPS, UPS, and FedEx. A \$25.00 per package handling fee, plus all applicable postage, registration, and insurance charges apply.
